"**Evaluation Version**" means a version of this Software that You may Use, without purchasing a license, for the maximum number of calendar days that is specified (the "Evaluation Period"). "**ACDSee 365**" means the online feature of ACDSee Photo Studio Ultimate 2024 which is subject to the terms of service contained within ACDSee 365.

2. Grant of Software License

ACD does not transfer title to this Software to You; the license granted to You is not a sale. Provided You comply with all the terms of this Agreement, ACD grants you the right to install and run the Software on one Device that you own and control.

2.2 Evaluation Version Use – You may Use the Evaluation Version of this Software for the Evaluation Period.
